The landfill is approximately 54 acres of disturbance which includes a 90 foot raven filled with garbage. A stream flows directly through the landfill and it has been diverted to avoid a park at the bottom. Owner intends to close and build a solar farm on the top. Applicant has revisions in here for us to approve. Mr. Dunn has informed him that he would need a new plan for the recycling material on the top. Motion by Member Bonin, seconded by Member Davis and all approved to deny revisions for plan without prejudice. Motion carried.
