**Manager Report- Joseph Dunn**

*Fenimore Landfill*

Mr. Dunn reported that we have a certification for a 150 acre landfill in Roxbury. A private owner purchased through a tax sale and would like to cap. There is a ravine filled with 190 feet of trash with a stream that runs through it. The landfill is not capped or closed.

We did issue approval for tree removal but now he must make submission for cap. The site needs significant redesigning and the DEP has issued a consent order. Penalties will apply if he does not comply.

The site has significant truck traffic with crushed concrete being trucked. There are concerns with runoff into stream. Site is significant health hazard.

Operational plan being presented to board today allowing trucks to build grade up.

Motion made by Member Davis, second by Member Nordstrom to allow Chair Welch and Manager Dunn to stipulate as many safe guards as possible for conditions on Fenimore Landfill Certification. Motion carried.

Mr. Dunn had a meeting in Florham park regarding property donated to Florham Park for recreations fields. There are two detention sites on the project. The Engineer is satisfied with all criteria.

**Extension-**Peter Nietzsche- Mr Nietzsche reported that the farmers have been hit hard by Hurricane Irene which reduced the pumpkin crop for this year.

Mr. Nietzsche also reported that the district will receive their \$25,000.00 Freeholder grant.

*Evasive plant program-* We are dealing with Water Chestnut on Kitchell Road. Hoping to eradicate but must be hand pulled and not much success. We are also dealing with “invasive mile a minute weed” which has been discovered in composting pile in Mt. Olive.

Mr. Nietzsche commented that there is a new Master Gardner program. It was suggested that maybe a Master Gardner might be willing to work in our nursery. Mr. Nietzsche and Mr. Dunn will discuss.

Mr. Nietzsche commented that Extension Service is working with the park commission on community gardens.
